Old Business

Status report from William Westerman on 2697 County Road 10 property renovation

Code Enforcement Officer Teed spoke with Westerman prior to the meeting. Mr. Westerman was given a 60 day deadline to meet a certain criteria, in which Westerman started a lot but, hasn't met all requirements. Code Enforcement Officer Teed indicated that he hasn't received stamped plans or a mold remediation test, which needs to be completed. Mr. Westerman has requested for a 180 days to complete the listed requirement and 365 days to complete the house. Mr. Westerman joined the Town Board meeting at 7:17pm. Westerman indicated he will be putting out a sign in front of the house, "Build to Suit", to see if he could get a potential buyer. Once that happens, he will be able to design a floor plan and complete the construction by the November 6, 2020 deadline.

The Town Board made a motion by Council Member Trickey, seconded by Council Member Sanford to amend Resolution #27-2019, section 3 to be extended the compliance date to May 6, 2020.
